



**NOTICE OF PROPOSED AMENDMENT TO THE
ELLIS COUNTY BAIL BOND RULES,
RULE NUMBER 103, CHANGING THE LOCATION
OF THE BAIL BOND BOARD MEETINGS,
EFFECTIVE APRIL 24, 2015**

Pursuant to Section 1704.104 of the Texas Occupations Code, the Ellis County Bail Bond Board, as part of its regularly scheduled March 27, 2015 meeting, will consider, discuss and take action as appropriate concerning an amendment to Rule 103 of the Ellis County Bail Bond Rules, moving the location of the Bail Bond Board meetings to the Grand Jury Room on the 2nd Floor of the Ellis Courts Building, 109 South Jackson, Waxahachie, Texas 75165. If the Bail Bond Board approves the amendment to Rule 103 of the Ellis County Bail Bond Rules, then the amendment would take effect on April 24, 2015 at 1:00 p.m. for the regularly scheduled April Ellis County Bail Bond Board Meeting.

The following are the proposed changes to the Ellis County Bail Board Rules:

Current Rule 103:

“Rule 103. Meeting Locations”

The Board shall meet in the Ellis County Commissioner’s Courtroom on the 2nd Floor of the Historic Ellis County Courthouse at 101 W. Main St., Waxahachie, Texas, unless notice is posted otherwise.”

Proposed Change to Rule 103:

“Rule 103. Meeting Locations”

The Board shall meet in the Grand Jury Room, 2nd Floor of the Ellis Courts Building, 109 S. Jackson St., Waxahachie, Texas, unless notice is posted otherwise.”

This Rule Change, if approved, will take effect on April 24, 2015 at 1:00 p.m. at the regularly scheduled April Meeting.

Consideration, discussion, and action as necessary will be an agenda item for the Ellis County Bail Bond Board on March 27, 2015 at 1:00 p.m. at the regularly scheduled March meeting in the Commissioners Courtroom, 2nd Floor of the Historic Ellis County Courthouse, 101 W. Main Street, Waxahachie, Texas 75165. If the Board votes to amend Rule 103, thereby changing the location of the Ellis County Bail Bond Board Meetings, then the attached Ellis County Bail Bond Board 2015 Meeting Schedule as Amended March 27, 2015 will be presented to the Board for approval and dissemination.
